WHISTLEBLOWER FIRSTHAND KNOWLEDGE OF ICE AGENT JONATHAN D. ROSS

FULL RELEASE DATE (LATE JANUARY 2026)

Department of Homeland Security Secretary Kristi Noem, Assistant Secretary for Public Affairs, Tricia McLaughlin, ICE Acting Executive Associate Director of Enforcement and Removal, Marcos Charles, ICE Deputy Director Madison Sheahan and Tactical Commander Bovino have issued a secret and highly guarded unwritten and undocumented directive to accompany “OPERATION METRO SURGE SECTIONS I AND II, called the “AOC DIRECTIVE” which stands for ANTAGONIZE, ORCHESTRATE, CAUSE. The directive is named after House Representative Alexandria Ocasio Cortez due to Kristi Noem’s immense hatred, contempt and wishes of harm and or death towards house member Cortez.

This Whistleblower report has been written and published by two former ICE applicants who decided to withdraw from and end their training to become ICE officers after Kristi Noem and Madison Sheahan personally addressed new ICE recruits revealing the AOC DIRECTIVE as part of their speech as to what will be expected of ALL ICE AGENTS.

ALL ICE AGENTS HAVE BEEN INSTRUCTED TO WILLFULLY, INTENTIONALLY AND PURPOSEFULLY CREATE SITUATIONS BY ANTAGONIZING ILLEGAL IMMIGRANTS AND EVEN AMERICAN CITIZENS, BY ORCHESTRATING SITUATIONS KNOWN TO RESULT IN HARM AND OR POSSIBLE DEATH TO THOSE BEING PURSUED, AND TO DIRECTLY CAUSE HARM AND OR DEATH AS IT WILL LEAD TO AN EASIER PATH TO RIDDING THE UNITED STATES OF ILLEGAL IMMIGRANTS AND CERTAIN “UNDESIREABLE” AMERICANS.

“ALL ICE OFFICERS HAVE BEEN TOLD THEY HAVE COMPLETE IMMUNITY, AND A PRESIDENTIAL PARDON AWAITS THEM SHOULD THEY VIOLATE THE LAW IN THE EXTREME, WHICH INCLUDES “RAPE AND MURDER”.

Whistleblowers have confirmed that Commander Bovino is at the heart of Directive AOC.

**AS TO AMERICAN CITIZENS, THEY ARE CONSIDERED ACCEPTABLE COLLATERAL DAMAGE, AND ALL ICE AGENTS ARE INSTRUCTED TO WRONGFULLY ARREST, CAUSE HARM AND OR DEATH TO AMERICAN CITIZENS ON AN OCCASIONAL BASIS FOR THE SOLE AND SINGULAR PURPOSE OF RIDDING AMERICA OF WHOM KRISTI NOEM CLASSIFIES AS UNDESIREABLE AMERICANS WHO DON'T BELONG. THE LGBTQ COMMUNITY IS A HIGHLY DESIRED TARGET FOR NOEM AND SHEAHAN.**

**As to ICE Agent Jonathan D. Ross. The whistleblowers who have revealed ICE DIRECTIVE AOC, have firsthand direct knowledge of statements, criminal acts, threats and promises of revenge made by ICE Agent Jonathan D. Ross. Following the incident involving Roberto Carlos Munoz-Guatemala, ICE Agent Jonathan D. Ross made his intentions towards both illegal immigrants and various American citizens well known. Our whistleblowers met ICE agent Ross on three occasions while briefly training to become an ICE agent. ICE agent Jonathan D. Ross told multiple trainees including our whistleblowers about his absolute hatred for illegal immigrants, jews, LGBTQ people, and Democrats. ICE Agent Jonathan D. Ross said his hatred for illegal immigrants started due to personal family issues between himself and his wife's family. ICE agent Jonathan D. Ross said his hatred grew into homicidal rage after he was severely injured during his incident with Roberto Carlos Munoz-Guatemala.**

**Upon the AOC Directive being issued, our whistleblowers said during one of their last confrontations with ICE agent Jonathan D. Ross, they overheard agent Ross say "NOW I HAVE A LICENSE TO KILL ANY DIRTY ILLEGAL I WANT AND SOME SCUM AMERICANS BECAUSE I CAN BREAK THE LAW, LIE, FALSIFY STATEMENTS AND INJURIES BECAUSE ALL ILLEGAL IMMIGRANTS AND SCUM AMERICANS CAN EITHER LEAVE OUR COUNTRY IMMEDIATELY OR DIE". Ross also divulged that a select variety of ICE AGENTS carry drop guns which are rotated between those select ICE AGENTS each day. Upon the full release of this report, our whistleblowers will reveal firsthand knowledge of known criminal acts and mental issues as to ICE agent Jonathan D. Ross during and after his enlistment in the United States National Guard. Our whistleblowers also have knowledge of 5,500 additional ICE AGENTS and 2,500 ICE trainees being deployed to Minnesota on or before January 20<sup>th</sup>, 2026. Our whistleblowers have risked their lives leaking this information as they receive weekly threatening phone calls and text messages from certain individuals, they trained with at the Department of Homeland Security, and from certain senior members of Homeland Security. "LET IT BE KNOWN THAT THE A.O.C. DIRECTIVE WAS PUT IN PLACE SPECIFICALLY FOR THE OPERATIONS IN MINNESOTA AS REVENGE AGAINST GOVERNOR WALZ BY PRESIDENT TRUMP.**
